1	A RESOLUTION recognizing the important role the hospitality industry can play in
2	preventing and disrupting child sex trafficking and encouraging Kentucky residents,
3	employees, and agencies to book travel and events at hotels, venues, and travel agencies

5	WHEREAS, 59% of all human trafficking victims in Kentucky are children; and
6	WHEREAS, an estimated 199,000 incidents of sexual exploitation of minors occur
7	each year in the United States;
8	WHEREAS, between 244,000 and 325,000 American youth are considered at risk
9	for sexual exploitation;
10	WHEREAS, children as young as 12 and 13 are often bought and sold into the sex
11	industry alongside adults; and
12	WHEREAS, the American Hotels and Lodging Association recognizes that
13	trafficking networks often rely on legitimate businesses, including hotels, to sustain their
14	illegal operations and infrastructure; and
15	WHEREAS, one of the most commonly reported venues for sex trafficking to the
16	National Human Trafficking Hotline is hotels and motels; and
17	WHEREAS, 45% of youth victims are exploited in hotels; and
18	WHEREAS, 52% of U.S. hotels have received training to help prevent child sex
19	trafficking; and
20	WHEREAS, hotel employees are more likely to witness human trafficking than the
21	average person and can be trained to recognize and report suspected incidents to the
22	authorities; and
23	WHEREAS, hotel managers and associates who have undergone training are much
24	more aware of child sex trafficking and relevant state law (93%) than those who have not
25	been trained (17%); and
26	WHEREAS, criminal activity presents a great risk for the safety and security of
27	hotel businesses, as well as legitimate hotel customers; and

1	WHEREAS, the Commonwealth of Kentucky has a vested interest in the safety of
2	its citizens and visitors and wants to expose any safe havens for child traffickers; and
3	WHEREAS, recommending travel to hospitality and convention venues that

5	stewardship and awareness within the hospitality industry; and
6	WHEREAS, the Tourism Child-Protection Code of Conduct is an established
7	initiative to provide support to the travel and tourism industry in preventing the sexual
8	exploitation of children; and
9	WHEREAS, ECPAT-USA training is already available to 40% of the total hotel
10	properties in the United States;
